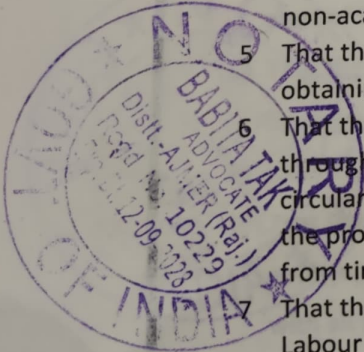
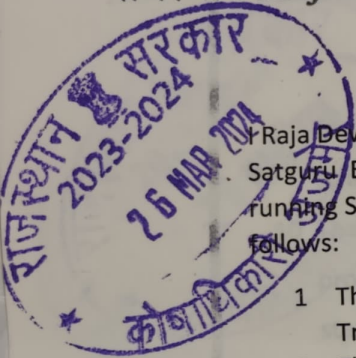
- 1 That Satguru Educational and Charitable Trust is a registered Trust under the Indian Trust Act.
